Candidates Forum

Speaker: Quentin Palfrey, Democratic Candidate for State Attorney General

Exploring the possibility of running for State Attorney General. This would only go forward if Maura Healey decides to run for governor. If she remains as Atty General he would bow out as a candidate.

Backgound: worked in the Atty General's office for a few years as an Assistant Atty General. Worked in the Obama's administration as Sr Advisor for Jobs and Competitiveness. Also was Acting General Council of US Dept of Commerce where he oversaw 400 lawyers from

inauguration day thru the summer. Involved in the creation of the Build Back Better bill and overseeing the census.

There are 4 issues that he believes he can have the most impact on being State Atty General. Must look to the state for leadership instead of waiting for the federal government to step in.

- 1) Crisis of inequality and consumer protection
- 2) Racial Reckoning, policing reform and housing justice
- 3) Climate Crisis
- 4) Health Insurance

Has a vision of working his campaign beginning with a grassroots movement.

Questions:

Alice W. – American Values, what do you think they are?

Find ways of building bridges we disagree with to make democracy work. Wanting to be proud our country again.

Laura W. – What would you prioritize in the criminal justice area.

Focus more on criminal justice and policing reform. Imprisoning too many people for too long for too minor of a crime. Race has too much to do with who ends up in the criminal justice system. We criminalize poverty. Need to do more about pretrial detention, re-entry into society, solitary confinement. Homelessness, mental health and substance use disorder challenges are not part of police purview. This is a Social Services challenge. Need to provide housing and better care services. Incarceration will never be the answer to opioid crisis or homelessness. Need to be more agressive in police reform.

Lee H. – Public Corruption Unit (state) has taken a backseat lately. Would you refocus on this if you become Atty General?

During the last 4 yrs-Trump Administration- the current Atty General has worked more on the federal side of corruption out of necessity. Now that we are under the Biden Administration there will be more focus on the state corruption side Health Care, Medicare/Medicaid fraud and to re-establish the Public Corruption Unit with its own leadership.

Beacon Hill Round-up

Danielle Gregoire; State Rep, 14th Middlesex District

Received \$500,000 for Marlborough from the State's American Rescue Plan thru both our state reps hard work, Danielle and Carmine Gentile. President Biden has signed the Infrastructure Bill which will be bring \$12 billion to Massachusetts. The House Speaker has requested Danielle to head the project of finding the best way to spend the infrastructure funding to help our citizens have better lives. Attended briefing with Secretary of Transportation Pete Buttigiege and will be meeting with Labor Secretary Marty Walsh later to go over ideas.

End of session anticipate going over Healthcare Reform, Energy legislation and potential reforms around Soldier's Homes and how we treat our veterans which was subsequent to our Veteran's Bill Danielle shepherded thru the process earlier this year.

Redistricting is now settled. Danielle's district #14 will now include 12 out of 14 of her previous Marlborough precincts plus 2 precincts in Framingham.

Questions:

Dan Caruso: Are the Framingham Districts new?

The districts are brand new due to Rep Robinson in Framingham leaving.

Barbara Allen: Have you scheduled a date for your kick off and when is filing date due for your position.

The filing date begins in February and due around tax day, April 15th and my Kick-Off event will be in April. No final date has been scheduled yet.

Babs Fenby: Will Police Dogs ride in ambulances when there are serious episodes to check their mental health as well?

The Senate has just passed this law unanimously. Danielle supports this.

Dave Doucette: Is the money from the American Rescue Plan and Infrastructure Bill going to city and towns directly? How will this be spent? Also is there going to be any expansion of the rail service between Boston and western part of the state?

ARP money is going to cities and towns directly. Governor Baker mistakenly believed that he should be in charge of the disbursement of the money. The House disagreed and fought to have them be the ones to make the decisions of how the money should be spent. This is why the Speaker of the House chose Danielle to head the money distribution from the Infrastructure Bill before Gov Baker took it over.

Danielle was in a meeting with over a 100 of her colleagues this summer and the East/West Rail was on the top of the list for use of funds from the Infrastructure Bill.
